Request for Expression of Interest (EOI) for recruitment of Capacity Development Consultant (GIS Based Development of Rural Road Master plan) Deadline for Submission of EOI: 10-12-2020

CALL FOR EXPRESSION OF INTEREST (EOI)

- The Government of the People's Republic of Bangladesh has received a loan for financing from the Asian Development Bank (ADB) for the Rural Connectivity Improvement Project (RCIP) to improve the Rural Road Network in Bangladesh and intends to apply a portion of the proceeds of this loan to eligible payments under the consultancy services for which this invitation for Expression of interest (EOI) is issued.
- 2. The overall objective of the assignment is to provide LGED with technical and management support to plan and implement the prioritization system of rural roads for development/improvement through preparation and up gradation of identified roads under LGED using state-of-the-art geo-referencing and GIS techniques and web-based applications. The broad objectives of this assignment are to develop a system to ensure: i) Sustainable management of rural roads; ii) Utilization of resources to ensure value for money rationally; and iii) Prioritization of rural road hierarchy and promote transport planning methodologies.
- 3. It is estimated that the CDC will require about 4816 person-months national rendered over 24 calendar months from commencement date. The estimated cost is about 626.98 million BDT (Equivalent \$ 7.55 million). A detailed description of the requirements is provided in the Terms of Reference (TOR) available on the ADB website (http://csrn.adb.org).
- 4. The Executing Agency (EA) for the project is LGED under the Local Government Division (LGD) of the Ministry of Local Government, Rural Development and Cooperatives. Eligible consulting firms are invited to express their interest in the assignment. The expression of Interest (EOI) must be submitted online through the ADB's website following the procedures described below.
- 5. To submit an EOI: (1) register with ADB's Consultant Management System at ADB website (<u>http://www.adb.org</u>); click "About ADB", "Consulting Services", and "Consultant Management System;" (2) go to <u>http://csrn.adb.org</u>; (3) click on "Bangladesh", (4) find the name of the captioned project; and click on "View CSRN;" (5) click on "Express Interest", and (6) follow the instructions. All requested information must be provided in the respective EOI fields completely.
- 6. The EOI must be submitted online before or on 10-12-2020. A consulting firm will be selected in accordance with ADB's quality and cost based selection (QCBS) set out in the ADB Procurement Policy: Goods, Works, Non-consulting and Consulting Services (2017, as amended from time to time) and Procurement Regulations for ADB Borrowers: Goods, Works, Non-consulting and Consulting Services (2017, as amended from time to time).
